

### **Statement attributable to Health Minister, Josie Osborne**

“After hearing the thoughtful feedback of Traditional Chinese Medicine (TCM) practitioners, I have directed the Ministry to make changes to the TCM regulations under the Health Professions and Occupations Act (HPOA) to clarify that activities related to Chinese herbal formulae are restricted and fall under the purview of regulated/licensed traditional Chinese medicine practitioners, doctors of traditional Chinese medicine, and traditional Chinese medicine herbalists.

Traditional Chinese Medicine (TCM) and acupuncture are important health professions in our province, relied upon by many people to support their health and well-being.

As part of the modernization of the Health Professions Act, the Health Professions and Occupations Act (HPOA) was developed with the aim to improve public protection and safety in the health system. New profession-specific regulations were also developed, with no intended change to the scope of practice for traditional Chinese Medicine practitioners and acupuncturists who are authorized to provide health services under the governing legislation.

Feedback from TCM practitioners clearly indicates that the new regulation governing their activities requires greater clarity to ensure public protection is not compromised. It is important that we get the regulation right – not only for public safety, but also the integrity of the profession.

I understand that traditional Chinese medicine is important to many people and communities in B.C., which is why our government funded the establishment of Canada’s first public bachelor’s degree program in TCM at Kwantlen Polytechnic University to help strengthen the long-term development of the workforce.

I want to sincerely thank everyone who supports B.C.’s TCM professionals, Kwantlen Polytechnic University’s TCM department, The British Columbia Association of Traditional Chinese Medicine and Acupuncture Practitioners (ATCMA), training institutes, the College of Complementary Health Professionals of BC, and Minister Anne Kang for sharing their knowledge and expertise with me at this time.”
